Nahendran Navaratnam is Head of Chambers at Navaratnam Chambers. He is a graduate of Monash University, Australia and holds a Bachelor of Science and Bachelor of Laws. Nahendran was called to the Malaysian Bar in 1988 and has vast experience handling trial and appellate work in large corporate, commercial and administrative law disputes for private and public listed companies, major international and Malaysian financial institutions, multinational corporations and professional practices. He also acts in professional liability, tax, construction and in commercial arbitration disputes.

He also handles libel work, having acted in several high profile libel suits including several both for and against leading local and international publications. He is especially familiar with capital markets and securities industry regulatory and enforcement disputes having acted for and advised industry regulators.

He has also served as an elected representative of the Kuala Lumpur Bar and as past Chairman of Kuala Lumpur Legal Aid.

He is a regular coordinator and course leader for Advocacy courses conducted by the Malaysian Bar.

He served for two years on appointment by the Chief Justice of Malaya on the Advocates and Solicitors Disciplinary Board to deliberate on disciplinary complaints against lawyers.

He was a member of the judiciary reform committee of PEMUDAH, treasurer of the Malaysian Institute of Arbitrators, a member of the Rules Reform Committee of the Malaysian Bar and is listed to receive appointments as Arbitrator with the Kuala Lumpur Regional Center for Arbitration (KLRCA), the Chartered Institute of Arbitrators and the Malaysian Institute of Arbitrators and the Singapore International Arbitration Centre (SIAC) and has also been appointed by the International Chamber of Commerce (ICC).

Nahendran is a Chartered Arbitrator and has been appointed as Arbitrator privately and by institutions such as the ICC, SIAC and the KLRCA both as sole arbitrator and as member or chairman of an Arbitral Tribunal. He is an accredited mediator and is a member of the Malaysian Bar and Securities Industry Dispute Resolution Center, Mediator Panel and is also a trained adjudicator on the KLRCA panel of adjudicators.
